SPECIAL TOWN MEETING OF TOWN OF UNION ELECTORS
MONTHLY BOARD MEETING
MINUTES of Thursday, November 13, 2014**

The Town of Union held a **Public Budget Hearing** on **Thursday, November 13, 2014 at 6:30 p.m.** at Creekside Place, 102 Maple Street, Evansville, WI on the **Proposed 2015 Budget**.

A **Special Town Meeting of Town of Union Electors** was held immediately following the Public Budget Hearing and was called pursuant to §60.12(1)(c) of Wisconsin Statutes by the Town Board for the following purposes. Each item included a public hearing:

1. To adopt the 2015 Town tax levy of all or part of the sum needed to balance the budget with balance to be taken from the surplus pursuant to §60.10(1)(a).

Closed at 6:56. Motion to raise levy approved. Gruebling motioned to approve budget as written. Schneider second. Motion carried.

2. To authorize the Town Board to hire Town officers as employees of the Town and set an hourly wage pursuant to §Sec. 60.10(1)(g).

No officers or employees were hired. Raises were not pursued for any positions. Sharon Franklin made a motion to leave the rate at \$15/hour. Kendall second. Motion carried.

Schneider motioned to close meeting at 7:02 and Sharon Franklin second. Meeting closed at 7:02 with no public input.

The **Town of Union Monthly Board meeting** was called to order by Chairman Kendall Schneider at 7:03 p.m. on Thursday, November 13, 2014, at Creekside Place, 102 Maple Street, Evansville, WI. Members in attendance included Chairman Kendall Schneider and Supervisor Kim Gruebling. Treasurer Sharon Franklin, Clerk Bridgit Larsen, and Building Inspector Bob Fahey were also in attendance. In observation of Veteran's Day and a moment of silence was held to honor those who have served and currently serve followed by the reciting of the Pledge of Allegiance.

Clerk's Minutes (October 2, 2014)

October 4, 2014, meeting minutes were approved by Gruebling. Schneider second. Motion carried.

Peg Berg Trust - Fencing

Evansville's EMS Contract is due. Schneider stated the total will again be three equal payments of \$38,960.00. Schneider made motion to approve. Gruebling second. Motion passed

Jerry stated we're slowing down for the winter. Schneider questioned if there is enough heat (propane) for the approaching winter months. Jerry confirmed there is.

Board Action: Approval of 2015 budget

Schneider brought forward the 2015 budget. Gruebling made motion to approve. Schneider second. Motion carried.

Public Hearing

At 7:15 the public hearing was opened.

Review and action: request made by Kim Wincapaw of 3845 U.S. Highway 14, Janesville, WI, 53548 to approve a land division. The Wincapaw's were present for their requested Land Division. 96 acres of tillable farm land, and they want to sell off 3-acres with the house on 18442 West County Road C.

Gruebling motioned to approve land division. Schneider second. Motion carried

Pay Bills

There being no further business to come before the Board, a motion to adjourn and pay bills was made by Schneider/Gruebling. Motion carried by unanimous voice vote. Meeting adjourned at 7:35 p.m.
