Monthly Board Meeting  
Minutes of March 8, 2022**

The Town of Union Monthly Board meeting was called to order by Chairman Kendall Schneider at 6:32 p.m. on Tuesday, March 8, 2022 at the Town of Union Town Hall, 15531 W.
