9. Roadwork Update & LRIP Application

Wethal reports Evansville-Brooklyn Rd is done, first layer of shoulder is in. Tuning up on Croft and then hopefully chipseal to Croft next year. Wethal is going to talk with company that chews up asphalt and lays it back down as a cheaper option. Schneider is in talks with Duane Jorgenson on Croft Rd also. May qualify for TRIP funds for double seal coat. Holt & Crocker on list soon too.
